

Information about IRB Approval for RIFA Projects

Does my project need review by the Internal Review Board (IRB)?

YES, if you are doing human subject research. Human subject is defined by DHHS as:

A living individual about whom an investigator (whether professional or student) conducting research obtains (1) data through Intervention or Interaction with the individual, or (2) information that is both Private Information and Identifiable Information.

In other words, if you are interacting (communicating or observing) or intervening (administering a procedure, changing the environment, etc.) with humans to obtain data about them for research purposes, then you must submit the project as human subject research and should be submitted to the IRB.

Likewise, if you are obtaining for research purposes private information that is identifiable to the individual about whom it pertains, then you must submit the project is human subject research and should be submitted to the IRB.

Is my project exempt?

Your project may be EXEMPT, EXPEDITED, or need FULL BOARD review. Even if your project is in the “exempt” category, you must still submit your project for IRB review and approval of its exemption. Exempt research includes: anonymous surveys/interviews or passive observation of public behavior with collection of identifiers.

How do I submit a project for IRB review?

1. Determine if IRB Review is required (using guidelines above and various worksheets found on [UC Davis Office of Research – Does My Project Need Review by the IRB](#))
2. Read the [Investigator Manual](#) (UC Davis)
3. Complete the online [CITI Training](#) – CITI Basic Human Research Protections Training (likely the social and behavioral research course). The training is [free](#) through your university (all UC campuses).
4. Create an [IRBNet Account](#). Two forms are mandatory: the *Initial Review Application* and *HRP-226 Administrative Approval*. After the Initial Review Application is complete, you will be presented with a list of other necessary documents.
